Small Practice Traineeship Grant Scheme

[to assist in the employment of trainee solicitors by solicitors' practices located in specified geographical areas]

1. Objectives of the Scheme

- (a) As an outcome of the recent state-wide study of smaller solicitors' practices ("practice(s)") conducted on behalf of the Law Society of Ireland (the "Society") by Crowe Howarth (see, specifically, recommendations 9 & 10 of their report), the Society this year (2021) is continuing with its promotional scheme designated the "Small Practice Traineeship Grant Scheme (the "Scheme") designed to assist selected practices within specified geographical areas that are <u>not</u> located in the City and County of Dublin and the City of Galway, Metropolitan District of Limerick City and the City of Cork by means of supplementing financially the direct costs related to employing trainee solicitors from the same or adiacent geographical areas. ¹²
- (b) The Society, in promoting and funding the Scheme, has decided that in the year 2021, five individual grants should be awarded to each of five practices selected from among practices that make an application.
- (c) The cash element of each such grant awarded will total €18,000 (eighteen thousand euro) to be remitted to a selected practice by equal monthly payments of €750 in arrears over the course of the two year period of in-office training of the proposed trainee solicitor concerned and will be in addition to a fee discount of €7,000 (seven thousand euro) on the proposed trainee solicitor's fees payable to the Society for attending the Professional Practice Course One ("PPC I") or the PPC Hybrid.

Recommendation 10: Promotion of quality of life in rural areas and value of experience gained working in smaller practices It is recommended that the Society and smaller practices themselves, alongside relevant development agencies, should promote the quality of life in rural Ireland through a range of initiatives, as a way of ensuring a sustainable regional legal services market.

¹ Recommendation 9: Joint promotion of the value of smaller practices: Both smaller practices and the Society should promote the value of legal services, of sole practitioners and smaller legal practices specifically, as well as the benefit for clients of the general practice model.

2. Eligibility Criteria and other Conditions

- (a) The eligibility criteria for making an application to the Scheme for a grant are as follows:
 - the applicant practice where the training contract is to be completed to be located within a specified geographical area, as defined;
 - ii. the applicant practice to consist of five or less solicitors, including principal, partner(s), consultant(s) and employed solicitor(s);
 - iii. the proposed training solicitor to be a principal or partner who holds a current practicing certificate and has at some stage held a practicing certificate for a continuous period of at least four years;
 - iv. the proposed trainee solicitor to be identified and to consent to the application being made and who should have passed the Final Examination First Part ("FE-1") before 2 July 2021; and
 - v. the applicant practice to commit to paying the proposed trainee solicitor during the two year period of in-office training at least the "living wage" (currently €12.30 per hour), if awarded the grant.
- (b) The format of the application form is set out in Appendix A hereto and, when completed, shall be submitted either by post (addressed to Small Practice Traineeship Grant Scheme, Traineeship Section, Law Society of Ireland, Blackhall Place, Dublin 7, D07 VY24, DX79 Dublin) or by email (traineesection@lawsociety.ie) by no later than 2 July 2021.
- (c) Each applicant practice, in so applying, acknowledges to the Society that:
 - i. the decision of the adjudicating panel in selecting the five practices to be awarded a grant shall be final and conclusive; and
 - ii. in the event of being successful, if any resultant training contract did not proceed at all or was terminated before the end of the two year period of inoffice training of the trainee solicitor concerned the monthly payment of instalments of €750 cash grant would thereupon cease and the training practice will be paid a total grant amount pro-rata to the number of months of the in-office training period completed at the practice by the trainee solicitor unless the training contract was proceeding by reason of an assignment of the training contract to another eligible solicitor who was a principal or a partner within the same practice.
 - iii. the successful practices who are awarded a grant undertake to notify the Traineeship Executive immediately if a training contract in respect of a grant aided trainee solicitor is terminated.
- (d) Each application received will be assessed by the adjudicating panel having regard to the proposal (of a maximum of 1,000 words) submitted as part of each application, which should be indicative of the range of experience the proposed trainee solicitor might gain during his/her two year period of in-office training the Proposal to be marked by the adjudicating panel up to a maximum of 35 points (see Appendix B "Marking Scheme").
- (e) In addition (and reflective of the statistics of numbers of trainee solicitor admissions to the PPC I during the 2018 to 2020 period and the recorded county location of each

- trainee solicitor, as set out in the schedule hereto), bonus marks may be granted in respect of applications from practices located in particular counties showing zero or very low admission levels to be marked between 5 and 10 points (see Appendix B "Marking Scheme").
- (f) Finally, 5 bonus points may be awarded to an application from a practice which has not employed a trainee solicitor in the 2018 to 2020 period, (see Appendix B "Marking Scheme").
- (g) The adjudicating panel will consist of three members of the Society's Education Committee along with Ian Ryan, Traineeship Executive and Michael O'Mahony, Consultant to the Education Committee.
- (h) The successful applicant practices will be notified by 3 August 2021 in sufficient time that should enable:
 - applications to be made to the Society by each proposed trainee solicitor concerned for consent to enter into a training contract with each nominated proposed training solicitor concerned;
 - ii. (subject to such consent being forthcoming) the training contract to be signed by each party and registered with the Society; and
 - iii. each trainee solicitor concerned to enter on to the Professional Practice Course One or the Professional Practice Course Hybrid commencing later in 2021.
