Mr. Flanagan and I were also instructed by Wexford County Council in a similar case which as of June, 2018 is still ongoing.
- (ii) In December, 2017 successfully applied to the Irish arbitration Judge to enforce an Arbitration Award.
- (iii) As sole-arbitrator, in 2017, I sat in a very protracted c. €1 million dispute between an insurance company and a policy holder where the insurance company declined to meet a material damage claim as it alleged fraud. I issued a number of interim Awards which were not challenged by the parties. Each party was represented by a very senior member of the Irish Bar.
- (iv) As part of a 3 member Tribunal in a DIFC-LCIA arbitration arising from a property transaction I issued along with my colleagues an Award on jurisdiction in an arbitration which as of June, 2018 is still ongoing.
- (v) A Chartered Arbitrator from Africa selected me to be there Tribunal Secretary in a Telecommunications dispute which was to involve a 3 day hearing in 2018 but was compromised after I had worked as Tribunal Secretary in this LCIA dispute for some months.
