BENEFITS OF EMPLOYING A TRAINEE SOLICITOR

- Your organisation can grow its legal team whilst moulding the trainee solicitor to suit the relevant organisation's needs.
- 2 Trainee solicitors receive professional training in the law that is both relevant and current and this can aid in bringing important legal knowledge and skills back to your business as various areas of law evolve.
- **3** Trainee solicitors bring enthusiasm and energy.
- 4 Trainee solicitors may help you to grow your organisation and become more profitable.
- 5 Having a trainee solicitor in situ will make delegating important legal work easier.

6 The training contract also offers the training solicitor and their staff an opportunity to grow and improve essential management skills whilst making a valuable contribution to the social responsibility of training the next generation of solicitors.

As the solicitor professional qualification attracts a diverse student population including graduates wishing to switch careers, today's trainee solicitors may bring with them additional valuable skills including IT, second languages and accounting.



WORK PLACEMENTS

Offering a period of paid work experience is an ideal way to assess whether a candidate will fit into your organisation. Many trainee solicitors work in a variety of paid temporary work placements prior to obtaining their training contract. It provides these candidates with a valuable opportunity to gain relevant legal work experience whilst broadening their network of legal contacts.

WHAT AREAS OF PRACTICE CAN A TRAINEE SOLICITOR COMPLETE?

Every training contract is different. Trainee solicitors work in a diverse range of industries. Some trainee solicitors work in-house or in the public sector whilst others work in private practice.

IN RESPECT OF THE AREAS OF LAW IN WHICH A TRAINEE SOLICITOR MUST ATTAIN EXPERIENCE, THE FOLLOWING RULES APPLY: Trainee solicitors must obtain reasonable and appropriate instruction and experience in any three distinct areas of law to include working on contentious and non-contentious matters.

If it is the case that you cannot provide training in three distinct areas of law, you can always arrange a secondment in order that the trainee solicitor may obtain the missing area.

RECRUITMENT

You will need to recruit an individual who has successfully completed the Law Society Final Examination First Part (FE-1). <u>FE-1 DETAILS</u>

- 1. You could advertise your vacancy for free on the Law Society Finding Your Training Contract forum. Just email <u>traineeship</u> with the vacancy details.
- 2. You could advertise your vacancy on <u>www.legalvacancies.ie</u>
- 3. You could add your firm's details to the <u>register of firms</u> who take on trainee solicitors.

ELIGIBILITY TO BECOME A TRAINING SOLICITOR

- 1. You must at some stage have held an Irish practising certificate for a period of four years.
- 2. You must currently hold an Irish practising certificate.
- 3. If working in private practice, you must be either a partner or principal.
- 4. A training solicitor may have two trainee solicitors apprenticed to them at any one time and one more trainee solicitor for every two assistant solicitors employed.

REGISTRATION

In order to obtain the Law Society's consent to register a training contract, the important documents to be completed are:

- 1. FORM 1 for proposed trainee solicitor to complete
- 2. FORM 2A or FORM 2B for proposed training solicitor (Form 2A) or training manager (Form 2B) to complete
- 3. CODE OF CONDUCT to be signed by both proposed trainee solicitor and proposed training solicitor / training manager

Once the Law Society has approved the proposed training contract, the Indenture Deed (training contract) will be issued for completion and execution by both the proposed trainee solicitor and the proposed training solicitor. The signed Indenture Deed may then be returned to the Law Society for registration.

IN-OFFICE TRAINING PERIOD

The in-office training period is of twenty four months' duration and commences fourteen days after the last Professional Practice Course (PPC) exam. A trainee solicitor is required to obtain experience working in any three distinct areas of law to include working on contentious and non-contentious matters.

PROFESSIONAL PRACTICE COURSE (PPC)

Trainee solicitors may attend either the full-time PPC which runs from September to April or the Hybrid PPC course (part-time & distance learning) which runs from December to the following December.

Trainee solicitors are required to complete four Advanced Electives after completing the PPC course. The Law Society runs the Advanced Electives in two blocks each year taking place in May and June respectively.

THE QUALIFICATION PROCESS

The steps to qualify as a solicitor in Ireland are as follows:

1 Preliminary Examination for non-graduates.

- 2 Final Examination First Part (FE-1) consisting of 8 individual subjects
- Secure a training contract. Apply for consent to enter into indentures of apprenticeship and have the indentures registered with the Law Society.
- Complete the full time Professional Practice Course (PPC) Runs from September to the end of April [full-time] or December to the following December [PPC Hybrid, part-time, blended learning].
- Complete the In-office Training Period which starts 14 days after PPC and is of 24 months duration.
- Following the PPC course, complete four Advanced Electives. [The Law Society offers the Advanced Electives in two blocks each year, taking place in May and June respectively.
- Trainee solicitors can apply for admission to the roll of solicitors once all exams have been passed, their training period is completed and confimation of their competence has been received from their training solicitor.



COSTS OF EMPLOYING A TRAINEE

Training solicitors are obliged to pay trainee solicitors at least the minimum wage under the terms of the National Minimum Wage Act 2000. The Law Society Education Committee has issued a non-binding recommendation that training solicitors consider paying their trainee solicitors at least the "living wage".

In order to attract the best legal talent, some organisations offer training contracts with increased salaries and in some case payment of the Law School Professional Practice Course fees. Training firms are not obliged to pay the course fees.

It may be tax efficient for an organisation to pay the Professional Practice course fees as the payment of same is a deductible business expense for tax purposes. Where the individual trainee solicitor is paying their fees, they can claim a tax refund in respect of same.
