He has also acted as a Consultant and examiner to the Law Society Law School since the late 1980's.

Commissioner for Oaths and Notary Public.

Appointed in 1986 by the President of the High Court as a Commissioner for Oaths, in April 2000, he made legal history when he was appointed as a Notary Public for the Cities and Counties of both Dublin and Cork. (Traditionally, a Notary Public was appointed for contiguous areas only and Bill Holohan is the first person to be appointed for both Dublin and Cork). The Chief Justice, Mr. Justice Ronan Keane, in appointing Mr. Holohan described him as "*pre-eminently qualified*".

Complaints Adjudication Panel for personal Insolvency Practitioners.

In 2015 he was appointed by the Minister for Justice to the Complaints Adjudication Panel for Personal Insolvency Practitioners, (a statutory body under the Personal Insolvency Acts), for a three-year term and in 2018 and 2021 was again reappointed for a further three-year term.

Charities Appeals Tribunal.

In 2016 he was appointed to the Charities Appeals Tribunal, (a statutory body established under the Charities Act 2009), for a five-year term and was again reappointed in 2021.

Alternative Dispute Resolution:

In the area of Alternative Dispute Resolution, he has acted as an ADR professional adviser, and as an arbitrator/conciliator/mediator, in hundreds of cases.

With Keith Kelliher QS, another past Chairman of the Chartered Institute of Arbitrators, he is currently writing a book on ADR.
