Kate and Emma were very impressive in dealing with a number of sensitive International Humanitarian Law scenarios. The Brown Mosten International Client Consultation Competition (ICCC) is an annual competition for the winners of national competitions across the world. It provides an exciting opportunity for law students to learn and practice interviewing and counselling skills.



As our Quarter Final was bright and early the following morning, in the offices of Parisian Cabinet d'advocats, Cohen Amir-Aslani, we had a long night of preparation before we faced off against the Cardozo School of Law (New York). The key themes in this mediation involved the use of AI to assist recruitment, sustainability and time pressure. We then had the pleasure of attending a reception in the personal residence of the Indian Ambassador to France, Mr Jawed Ashraf, to eagerly await the news of the Semi-Finalists!

Despite an initial result mix up, we were thrilled to be through to the Semi-Finals. As a result of the timing, this round was almost a free shot with nothing to lose. Held in the ICC Headquarters, we met a formidable team from the experienced National University of Singapore. The dispute, arising from an alleged artistic copyright infringement, was

LAW SOCIETY WINS 2024 ICC INTERNATIONAL COMMERCIAL MEDIATION COMPETITION

Aoife O'Carroll, Clíodhna McHugh and Eoin Doyle, set off to Paris, under the watchful eye of coach, John Lunney, to represent the Law Society of Ireland in the 19th ICC International Mediation Competition. The team share their experience below.

As the Law Society's first entry into the week-long ICC Competition, there was certainly a learning curve in getting to grips with the format, with 46 teams competing from across 31 countries. All six rounds of mediation involved a commercial dispute, with a central document containing general information and another with corresponding confidential information. Before each session, we prepared an analysis of potential interests, BATNAs and an overarching strategy.

In the preliminary three rounds, we competed against the National Law University, Jodhpur; Panthéon-Assas University Paris II; and the Masaryk University. These mediations included a commercial landlord's dispute with their tenant, a fast-food company's supply chain issue, and an influencer's contractual obligation of content creation. It was great fun to meet teams from around the world and we were absolutely delighted to make it through to the Quarter Finals.

unlike previous rounds, as there was no pre-existing relationship prior to mediation. Much to our delight, after such an evenly matched session, we were through to the Final!

Held in the Émile Boutmy Lecture Hall of Sciences Po University, we faced off against the University of Marburg, with the added bonus in knowing that our families and friends were watching via the YouTube livestream at home. Having had the pleasure of a pre-tournament practice round against our fellow Finalists, this felt like a real fullcircle moment and we knew it would be tight! In the Final, we acted as a city's transport authority, with a dispute arising due to safety concerns regarding our supplier's trams. Ultimately, we were over the moon to get across the finish line and secure the win to bring the David Platt trophy home to Blackhall Place!

28 law school teams participated in the competition which was hosted by Loyola University in Chicago and included an intensive day of expert training for participants.

In the competition, teams of three students each go through three preliminary rounds serving as mediators, as well as advocates and clients. Mediators work in pairs, with the co-mediators being from different schools.

This encourages students to recognize that mediation is about working together to reach a solution, rather than competing at every turn. Mediators are judged on their ability to work together with their co-mediator in addition to their listening skills, their ability to help that advocates and clients see the strengths and weaknesses of their cases, their ability to stay positive and professional, and their ability to help guide the parties to a resolution of the dispute that brought them to mediation.

The Law Society team advanced to the final rounds in both Mediation and Advocate / Client categories and were prize winners in all categories.


### SUCCESS FOR ENVIRONMENTAL LAW MOOTERS

LAW SOCIETY ANNOUNCES WATERFORD STUDENT AS WINNER OF NATIONAL GRÁINNE O'NEILL MEMORIAL LEGAL ESSAY COMPETITION STUDENTS EXAMINE HOW THE LAW CAN HELP ADDRESS CLIMATE CRISIS











The Law Society of Ireland has announced the winners of the National Gráinne O'Neill Memorial Legal Essay Competition at an event held at the Law Society on Tuesday 30 April 2024.

Transition Year student Patrick Galvin, Abbey Community College, Waterford was announced as the overall winner of this year's competition. The event was attended by 30 student finalists, their parents, guardians and teachers.

The competition received almost 140 essays from 48 schools across 16 different counties. Each student submitted a 1,500word essay examining the topic, "Climate Change Mitigation; the role the law can play in addressing the climate crisis."

President of the Law Society of Ireland Barry MacCarthy, said, "The Law Society is

committed to supporting legal education for the next generation. With this year's essay focused on climate change, the students offered passionate, engaging and reflective essays.

This competition encourages students to consider the law and help them understand how the law can impact issues that are close to their hearts and areas of their daily lives." Patrick's essay was selected as the top entry and won a €1000 prize, and cup for his school. The judges commended Patrick for his essay's superb analysis of the law. The judges said, "it was clear he was passionate about the law and the subject matter making him a deserving winner."

Commenting on his win, Patrick Galvin said, "I am so grateful to have won the top award at the Gráinne O'Neill Memorial Legal Essay Competition. I have learned so much

about the law, and how it impacts and helps climate issues. The competition allowed me to consider these issues deeper. "I would like to thank my teachers and school, Abbey Community College, Waterford for their encouragement in entering and my parents for their support." Jack Wu, Jesus and Mary Secondary School,

Enniscrone Sligo was awarded second place and Ella Mae Gavigan, Wilson's Hospital School, Westmeath came third. Two merit certificates were awarded to Conal McMahon, Saint Joseph's Secondary School Tulla, Clare and Evie Quigley Loreto College St Stephens, Green Dublin.

#### About the competition

The Gráinne O'Neill Memorial Legal Essay Competition honours the life and legacy of the late Judge Gráinne O'Neill. In 2014, Gráinne became the youngest judge in Ireland when to appointed to the District Court. Gráinne died in 2018 following a period of illness but, during her life and especially during her years as a judge, Gráinne worked diligently to apply the law in a fair, rigorous and compassionate manner. The competition was initiated by The Hon Mr Justice Keenan Johnson of the Circuit Court, in collaboration with the Midland Solicitors' Bar Association in 2019. This is the second year the competition has invited entries from transition year students across the country.

"I hope Gráinne would be honoured to know that her legacy is making a positive difference to the next generation of legal learners, encouraging education, and helping them understand better how the law impacts all in society," said Mr MacCarthy.

# LAW SOCIETY'S COMMITMENT **TO COMMUNITY ENGAGEMENT**

Every Tuesday a dedicated group of trainee solicitors visit the school and spend time reading with the senior infant students. Their perspectives and interpretations never cease to amaze and amuse us, enriching our shared learning experience.

The shared reading project exemplifies the Law Society's proud tradition of volunteering and giving back to the local community through valued partnerships. By nurturing a love for reading and learning, the Law Society and Stanhope Street Primary School are sowing the seeds for a brighter, more inclusive future for all - one story at a time.





# LAW SCHOOL COUNSELLING SERVICES - CELEBRATING 10 YEARS

This year, the Law Society proudly marks 10 years of dedicated investment in the mental health and wellbeing of the Irish legal profession. It all began in 2014 with the establishment of the trainee counselling service. Since then, 2,722 trainees from 385 legal workplaces have benefited from over 15,000 counselling appointments.

A significant milestone is that nearly a third (31%) of trainee solicitors since 2014 have

taken advantage of this valuable service. Fast forward to April 2024, and 50% of the 2023 PPC cohort has engaged with the service, clocking up just under 1,500 appointments (1,472) and counting!

The increasing uptake of counselling speaks volumes about its perceived usefulness. It underscores the service's role as a reliable source of support and professional development for trainee solicitors. Anonymous evaluation surveys



highlight that trainees highly value the Law Society's commitment to their professional wellbeing. They feel that counselling in an educational context boosts their confidence in completing professional duties, supports them in their personal life and aids their transition from Blackhall into the workplace. Additionally, trainees report that they have learned to seek assistance and support more easily, a crucial skill for avoiding serious ethical or technical challenges in the future. Since its inception in 2014, the Service has continually evolved. It now boasts a larger team of psychotherapists, extended hours, and the option of online therapy, adapting to the demands of modern working life. Our team of qualified psychotherapists and counsellors offer a bespoke model of counselling called Time Concentrated Therapy. Each of the team is skilled and highly experienced in working with trainee solicitors, at all stages of training. Our model of counselling is equally helpful when trainees are experiencing challenges or are would like to gain psychological skills and insight that will optimise the training experience and help them to prepare for practice.

The tasks set for the final were fun and interactive, each with a foundation in a legal case. 






# CONQUERING CARRAUNTOOHIL

### **CLIMBING FOR ACCESS TO JUSTICE IN IRELAND**



In August 2024, trainee solicitors Matthew Mulrooney (RDJ), Oliver Dunner (Addleshaw Goddard), Fearghal Ryan (Addleshaw Goddard), Sophie Walsh (A&L Goodbody), Dylan Byrne (Matheson), Daniel Donoghue (McCann Fitzgerald), Eoghan Davis (Oiger) and Hamzza Khosa (McKeever Rowan) will climb the highest mountain in Africa – Kilimanjaro. Their goal is to raise funds for and awareness of the Ballymun Community Law Centre, who perform incredible work throughout the community to ensure access to justice is available to all who need it. The trainees hope to raise €10,000 to equip the Community Law Centre with the necessary resources in order to provide legal services to the community and safeguard their commitment to ensuring access to justice for all.

In 2023 alone, Ballymun Community Law Centre answered 530 legal queries and provided 452 one-to-one consultations with a solicitor. The centre acts in areas of law that fall outside he protections of the Criminal Legal Aid and Civil Legal Aid schemes.

### CONDITIONAL CODING
